Privacy Notice

1. Your personal information (including your image) will be collected, used, disclosed and/or processed by CIMB for one or more of the following purposes:
 - (a) Processing your participation in the CIMB 3D Conquest, a regional team competition open to college and university students in ASEAN, who are interested in technology and innovation, good at analysing data and have an interesting idea to develop within the scope of the challenge;
 - (b) Responding to any enquiries by you;
 - (c) Dealing in any matters relating to the prizes, services and/or products which you may be entitled to under the CIMB 3D Conquest Terms and Conditions including the printing and mailing of correspondence, advices, information, notices or items to you, which could involve disclosure of certain personal data about you.
 - (d) If consented by you via your registration or participation in any contest, lucky draw, campaign, promotion, event, survey or questionnaire, to administer and provide you with such activities. Some of these activities have additional terms and conditions, which could contain additional information about how we use and disclose your personal data, so we suggest that you read these carefully;
 - (e) The organisation or running of the CIMB 3D Conquest, (Collectively, the Purposes).

3. In carrying out one or more of the above Purposes, CIMB may need to disclose your personal data to certain third parties, whether located within or outside Malaysia, as such third parties would then be processing your personal data for one or more of the above Purposes. You hereby acknowledge and agree that your personal data will/may be disclosed by CIMB to the following third parties (whether located within or outside Malaysia) for one or more of the above Purposes and for the said third parties to subsequently process your personal data for or more of the above Purposes:
 - CIMB Group Companies (means the groups of companies/legal entities of which CIMB Group Holdings Berhad, has a controlling interest, directly or indirectly, either by itself or through its subsidiaries) and between each of them;
 - companies and/or organisations that are or act as our agents, affiliates, service providers, business partners, professional advisers, other banks and/or financial institution, within or outside Malaysia, where necessary including Malaysia Airlines Berhad;
 - companies and/or organisations that provide services to us in communicating our products and services to you;
 - any other person notified by you as authorised to give instructions or to use the account(s)/facility(ies) or products or services on your behalf;
 - any person connected to the enforcement or preservation of any of our rights under your agreement(s) with us,

We will otherwise treat your personal information as private and confidential and will not disclose your information to anyone outside the CIMB Group except:

- where disclosure is to any of our assigns,
- where you have given permission;
- where we are required or permitted to do so by law;
- where required or authorised by any order of court, tribunal or authority, whether governmental or quasi-governmental with jurisdiction over CIMB Group;
- where we may transfer rights and obligations pursuant to our agreement(s) with you; and/or
- where we are required to meet our obligations to any relevant regulatory authority (whether in or outside Malaysia).

4. If you do not wish for CIMB to use your personal data or disclose your personal data for any of the above Purposes, you may withdraw your consent at any time by written notice to CIMB, pursuant to the Personal Data Protection Act 2010, however, depending on the circumstances and the nature/extent of your withdrawal, your withdrawal of consent may result in CIMB's inability to provide you with the services and products and hence may result in the termination of your relationship with CIMB or other consequences of a legal nature which may arise by virtue of your legal relationship with CIMB.
5. For the avoidance of doubt, in the event that Malaysia personal data protection law permits an organization such as CIMB to collect, use or disclose your personal data without your consent, such permission granted by the law shall continue to apply.
6. You agree that where your written permission is required by law or otherwise for any such disclosure by CIMB, the submitting of the registration form, personal data consent form and/or other methods of consent notification, as well as in any other manner permitted by law shall constitute and be deemed to be sufficient written permission for such disclosure.

7. Security Of Your Personal Information

Information is our asset and therefore CIMB Group places great importance on ensuring the security of your personal information. We regularly review and implement up-to-date technical and organisational security measures when processing your personal information.

Employees of CIMB Group are trained to handle the personal information securely and with utmost respect, failing which they may be subject to disciplinary action.

8. Retention Of Your Personal Information

CIMB Group will retain your personal information in compliance with this Privacy Notice and/or the terms and conditions of your agreement(s) with CIMB Group entities for the duration of your relationship with us, for such period as may be necessary to protect the interests of CIMB Group and/or its customers as may be deemed necessary, where otherwise required by the law and/or where required by CIMB Group's relevant policies.

9. What If Personal Information Provided By You Is Incomplete?

Where indicated (for example in application forms or account opening forms), it is obligatory to provide your personal information to us to enable us to process your application for our products or services. Should you decline to provide such obligatory personal information, we may not be able to process your application/request or provide you with our products or services.

10. Your Rights To Access And Correct Your Personal Information

We can assist you to access and correct your personal information held by us.

Where you wish to have access to your personal information in CIMB Group's possession, or where you are of the opinion that such personal information held by us is inaccurate, incomplete, misleading or not up-to-date, you may make a request to us via our Data Access Request Form or Data Correction Request Form respectively. These forms are available at our website.

We will use reasonable efforts to comply with your request to access or correct your personal information within 21 days of receiving your duly completed Data Access Request Form/Data Correction Request Form and the relevant processing fee (if any).

Please note that CIMB Group may have to withhold access to your personal information in certain situations, for example when we are unable to confirm your identity or where information requested for is of a confidential commercial nature or in the event we receive repeated requests for the same information. Nevertheless, we will notify you of the reasons for not being able to accede to your request.

Please also note that CIMB Group may use its discretion in allowing the corrections requested and/or may require further documentary evidence of the new information to avoid fraud and inaccuracy. You can also assist us to keep your personal information (such as your current mailing address) up to date, as it will enable us to serve you better.

11. Exercising Choices Over The Disclosure, Retention And Use Of Your Personal Information

Subject always to our contractual rights and obligations under relevant laws and regulations, you may exercise your choice in respect of the disclosure, retention and use of your personal information.
